AN ACT TO REZONE LOT NO. 22, BLOCK 9 IN THE MUNICIPALITY OF DEDEDO FROM RESIDENTIAL (R-1) TO COMMERCIAL (C).

BE IT ENACTED BY THE PEOPLE OF GUAM:

1 **Section 1.** Notwithstanding any other provision of law, the following
2 lot as described below is hereby rezoned from Residential (R-1) to
3 Commercial (C):

4 Lot No. 22, Block 9, in the municipality of Dededo, containing
5 an area of 1,12761± square meters, referenced to map filed
6 under Drawing No. E4-55-343, Instrument No. 34224.

7 **Section 2. Effective Date.** This provision contained herein shall take
8 effect immediately upon enactment of this Act.

9 **Section 3. Severability.** *If* any provision of this Act or its application
10 to any person or circumstance is held invalid, the invalidity *shall not* affect
11 other provisions or applications of this Act which can be given effect
12 without the invalid provision or application and to this end the provisions of
13 this Act is severable.
