AN ACT TO REZONE LOT NO. 22, BLOCK 9 IN THE MUNICIPALITY OF DEDEDO FROM RESIDENTIAL (R-1) TO COMMERCIAL (C).

## BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Notwithstanding any other provision of law, the following lot as described below is hereby rezoned from Residential (R-1) to Commercial (C):

Lot No. 22, Block 9, in the municipality of Dededo, containing an area of 1,12761± square meters, referenced to map filed under Drawing No. E4-55-343, Instrument No. 34224.

**Section 2. Effective Date.** This provision contained herein shall take effect immediately upon enactment of this Act.

**Section 3. Severability.** *If* any provision of this Act or its application to any person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this Act which can be given effect without the invalid provision or application and to this end the provisions of this Act is severable.
