AN ACT TO ADD SECTION 18 TO CHAPTER X OF PUBLIC LAW 32-068 (GENERAL APPROPRIATIONS ACT OF 2014) MAKING AN APPROPRIATION FROM THE TOURIST ATTRACTION FUND (TAF) TO GVB FOR MANHITA CHAMORRO.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that Manhita Chamorro is a non-profit Chamorro cultural organization that was founded to produce a documentary of the history of the Chamorro People. I Liheslaturan Guåhan further finds that a significant fundraising effort has been underway to support the production of this documentary and tremendous community support has been realized for this important project.

I Liheslaturan Guåhan further finds that revenue estimates for the Tourist Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Twenty-Nine Million Eight Hundred Eighty Thousand Nine Hundred Forty-Four Dollars (\$29,880,944), of which Twenty-Eight Million Five Hundred Thousand Dollars (\$28,500,000) is appropriated.

I Liheslaturan Guåhan further finds that the TAF revenues for Fiscal Year2014 are projected to exceed appropriations by One Million Three Hundred Eighty

1 Thousand Nine Hundred Forty-Four Dollars (\$1,380,944) and is available for appropriation.

Section 2. Section 10 of Chapter X (Guam Visitors Bureau) of Public Law 32-068 is amended to read:

Section 18. Appropriation to GVB for Manhita Chamorro. The sum of Fifty Thousand Dollars (\$50,000) is appropriated from the TAF to the GVB for Fiscal Year 2014 to Manhita Chamorro for the production of a documentary of the history of the Chamorro People. Notwithstanding the general provisions of § 30107.1, of Chapter 30, Title 11 GCA and this Act, this appropriation *shall* continue to be available until expended. The provisions contained in Section 15 (Service and Reporting Requirements) of Chapter X of Public Law 32-068 *shall* be applicable."

Section 3. Effective Date. The provisions contained herein shall take effect immediately upon the enactment of this Act.
