AN ACT TO ADD SECTION 20 TO CHAPTER X OF PUBLIC LAW 32-068 (GENERAL APPROPRIATIONS ACT OF 2014) MAKING AN APPROPRIATION FROM THE TOURIST ATTRACTION FUND (TAF) TO GVB FOR *INETNON GEFPÅ'GO* CULTURAL ARTS PROGRAM, INC.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that Inetnon Gefpå'go Cultural Arts Program, Inc. (Inetnon Gefpå'go) is an award-winning program whose mission is to promote awareness and pride in Chamorro heritage through performance arts. This is accomplished through youth interaction with traditional Master Artists, community presentations and cultural exchange. Membership in the group begins in middle school then continues into the community-based, high school and adult afterschool program where members further their cultural learning, continue performing throughout the island and represent Guam at major tourism promotions and festivals around the world.

I Liheslaturan Guåhan further finds that in November 2012, the Inarajan Garden House was purchased by a well-established and respected construction company doing business in Guam and Saipan, and that Inetnon Gefpå'go Cultural Arts Program, Inc. has been given a unique opportunity to develop a visitor

attraction venue that will provide cultural activities for our visitors, cultural arts
 training, and jobs for our southern residents.

I Liheslaturan Guåhan further finds that Inetnon Gefpå'go has been given a three (3) year use agreement with options for renewal to develop this four (4) acre property into a cultural arts academy where visitors can enjoy contemporary Chamorro cultural entertainment and family-oriented classes and events.

I Liheslaturan Guåhan further finds that revenue estimates for the Tourist Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Twenty-Nine Million Eight Hundred Eighty Thousand Nine Hundred Forty-Four Dollars (\$29,880,944), of which Twenty-Eight Million Five Hundred Thousand Dollars (\$28,500,000) is appropriated.

I Liheslaturan Guåhan further finds that the TAF revenues for Fiscal Year 2014 are projected to exceed appropriations by One Million Three Hundred Eighty Thousand Nine Hundred Forty-Four Dollars (\$1,380,944) and is available for appropriation.

Section 2. A New Section 20 of Chapter X (Guam Visitors Bureau) of Public Law 32-068 is added to read:

Section 20. Appropriation to *Intenon Gefpa'go* Cultural Arts Program, Inc. The sum of Twenty-Five Thousand Dollars (\$25,000) is hereby appropriated from the Tourist Attraction Fund (TAF) Inetnon Gefpago Cultural Arts Program, Inc. for the purposes of continuing their mission to promote and perpetuate the Chamoru language and culture. Notwithstanding the general provisions of § 30107.1, of Chapter 30, Title 11 GCA and this Act, this appropriation *shall* continue to be available until expended. The provisions contained in Section 15 (Service

- and Reporting Requirements) of Chapter X of Public Law 32-068 shall be
- 2 applicable."
- 3 Section 3. Effective Date. The provisions contained herein shall take
- 4 effect immediately upon the enactment of this Act.
