## BE IT ENACTED BY THE PEOPLE OF GUAM:

**Section 1.** Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that as a government, that as a government, we must do our part in an effort to

preserve and protect our unique language, culture, stories, identity, and resources;

5 instill a confidence and pride in our unique identity and our island community;

inspire a deep love for our water, land, and people; and promote sustainable and

healthy ways of living.

8 I Liheslaturan Guåhan further finds that revenue estimates for the Tourist

Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Thirty Million One

10 Hundred Sixty-Seven Thousand Three Dollars (\$30,167,003), of which Twenty-

Eight Million Five Hundred Thousand Dollars (\$28,500,000) is appropriated.

I Liheslaturan Guåhan further finds that the TAF revenues for Fiscal Year

2014 are projected to exceed appropriations by One Million Six Hundred Sixty-

Seven Thousand Three Dollars (\$1,667,003) and is available for appropriation.
