1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that as a government, that as a government, we must do our part in an effort to
4 preserve and protect our unique language, culture, stories, identity, and resources;
5 instill a confidence and pride in our unique identity and our island community;
6 inspire a deep love for our water, land, and people; and promote sustainable and
7 healthy ways of living.

8 *I Liheslaturan Guåhan* further finds that revenue estimates for the Tourist
9 Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Thirty Million One
10 Hundred Sixty-Seven Thousand Three Dollars (**\$30,167,003**), of which Twenty-
11 Eight Million Five Hundred Thousand Dollars (**\$28,500,000**) is appropriated.

12 *I Liheslaturan Guåhan* further finds that the TAF revenues for Fiscal Year
13 2014 are projected to exceed appropriations by One Million Six Hundred Sixty-
14 Seven Thousand Three Dollars (**\$1,667,003**) and is available for appropriation.

1 **Section 2.** A New Section 22 of Chapter X (Guam Visitors Bureau) of
2 **Public Law 32-068 is added to read:**

3 **Section 22. Appropriation to Guam Council on Arts and**
4 **Humanities Agency.** The sum of Thirty Thousand Dollars (\$30,000) is
5 hereby appropriated from the Tourist Attraction Fund (TAF) to Guam
6 Council on Arts and Humanities for the purposes of conducting
7 sustainability and capacity building workshops for local artists.
8 Notwithstanding the general provisions of § 30107.1, of Chapter 30,
9 Title 11 GCA and this Act, this appropriation *shall* continue to be
10 available until expended.

11 **Section 3. Effective Date.** The provisions contained herein shall take
12 effect immediately upon the enactment of this Act.
