1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds

3 that as a government, that as a government, we must do our part in an effort to

4 preserve and protect our unique language, culture, stories, identity, and resources;

5 instill a confidence and pride in our unique identity and our island community;

6 inspire a deep love for our water, land, and people; and promote sustainable and

7 healthy ways of living.

8           *I Liheslaturan Guåhan* further finds that revenue estimates for the Tourist

9 Attraction Fund (TAF) for Fiscal Year 2014 are tracking at Thirty Million One

10 Hundred Sixty-Seven Thousand Three Dollars (**\$30,167,003**), of which Twenty-

11 Eight Million Five Hundred Thousand Dollars (**\$28,500,000**) is appropriated.

12           *I Liheslaturan Guåhan* further finds that the TAF revenues for Fiscal Year

13 2014 are projected to exceed appropriations by One Million Six Hundred Sixty-

14 Seven Thousand Three Dollars (**\$1,667,003**) and is available for appropriation.

1           **Section 2. A New Section 24 of Chapter X (Guam Visitors Bureau) of**  
2 **Public Law 32-068 is added to read:**

3           **Section 24. Appropriation to Guam Humanities Council.** The  
4 sum of Twenty Thousand Dollars (**\$20,000**) is hereby appropriated from the  
5 Tourist Attraction Fund (TAF) to Guam Council on Arts and Humanities for  
6 the purposes of its operations. Notwithstanding the general provisions  
7 of § 30107.1, of Chapter 30, Title 11 GCA and this Act, this  
8 appropriation *shall* continue to be available until expended.

9           **Section 3. Effective Date.** The provisions contained herein shall take  
10 effect immediately upon the enactment of this Act.
