1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Authorization. Appropriation. Notwithstanding any other
- 3 provision of law, the sum of \$668,000 is hereby authorized appropriated from Fiscal
- 4 Year 2014 General Fund Revenues to the Guam Police Department for the purpose of
- 5 paying prior years overtime incurred by the Department.
