AN ACT TO ASSIGN THE FISCAL YEAR 2014 UNAPPROPRIATED BALANCE OF THE TOURIST ATTRACTION FUND TO THE GUAM COMMUNITY COLLEGE IN **SUPPORT OF** WORKFORCE DEVELOPMENT.



BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that the "Work Keys" assessment program used by the Guam 3 Community College (GCC) continues to help college students and others 4 5

seeking gainful employment provide potential employers with a reliable assessment of their math, reading, and other "real world" skills. According

to GCC, the "Work Keys" assessment program is used by thousands of 7

companies worldwide to help select, hire, train, develop, and retain a high-

performance workforce.

I Liheslatura further finds that GCC, the Guam Chamber of Commerce, and several of Guam's mayors have established partnerships aimed at increasing access to the "Work Keys" assessment program for

village residents seeking better employment opportunities. Recognizing
the value of helping job seekers prepare themselves for various
occupations in tourism and other industries on island, the Guam Chamber
of Commerce has furnished several community centers with basic
computer equipment for use by village residents who wish to study for and
eventually complete the "Work Keys" assessment program. Dozens of
residents have participated in training opportunities as a result of the

partnerships established between GCC, the Guam Chamber of Commerce,

9 and Guam's mayors within the last two years.

It is, therefore, the intent of *I Liheslaturan Guåhan* to extend the "Work Keys" assessment program to other villages in support of residents that are willing and ready to work towards earning a decent wage to support themselves and their families.

14 Section 2. Appropriation; Reporting Requirement.

Notwithstanding any other provision of law, the unappropriated Fiscal Year 2014 balance of the Tourist Attraction Fund is hereby assigned to the Guam Community College for the purpose of increasing access by eligible residents to the "Work Keys" assessment program including training, study and test materials. Funds shall be used to purchase basic computer equipment, supplies, and other necessary supports.

No later than six (6) months following the enactment of this Act, GCC shall submit a detailed report to *I Maga'lahen Guåhan* and to the Speaker of *I*

- 3 **Section 3. Effective Date.** This Act shall be effective upon
