AN ACT TO DE-APPROPRIATE SEVENTY-FIVE THOUSAND DOLLARS (\$75,000.00) FROM THE SUMS APPROPRIATED TO THE LEGISLATURE AND RE-APPROPRIATE SEVENTY-FIVE THOUSAND DOLLARS (\$75,000.00) TO THE GUAM MEMORIAL HOSPITAL AUTHORITY.

## BE IT ENACTED BY THE PEOPLE OF GUAM:

**Section 1.** The sum of Seventy-five Thousand Dollars (\$75,000.00) is de-appropriated from the sums appropriated to *I Liheslaturan Guåhan* prior to December 31, 2014 and reappropriated to the Guam Memorial Hospital Authority for: one (1) cryostat; two (2) BiPAP systems; and ten (10) infusion pumps. Notwithstanding any other law or rule, the Chief Fiscal Officer of the Legislature is authorized to reduce the allotment to Senator Michael T. Limtiaco by an amount equal to the sum de-appropriated by this section.
