3           **WHEREAS,** Miss Sharon Cuneta is a world-renowned recording artist  
4 and actress whose career began in 1981 with the movies "Dearheart" and "P.S.  
5 I Love You," released in the Philippines; and  
6           **WHEREAS,** Miss Sharon Cuneta has become one of the most regarded  
7 actresses in the Philippines; and  
8           **WHEREAS,** Miss Sharon Cuneta won the award for 'Actress of the  
9 Year' in the Philippines for the movies *Madrasta* in 1996; and  
10          **WHEREAS,** Miss Sharon Cuneta won the award for 'Best Actress' in the  
11 Philippines five times between 1997 through 2003; and  
12          **WHEREAS,** Miss Sharon Cuneta is married to Francis "Kiko"  
13 Pangilinan, Majority Leader Senator in the Senate of the Philippines 13<sup>th</sup>  
14 Congress and is the mother of three; and  
15          **WHEREAS,** Miss Sharon Cuneta was born on January 6, 1966; and  
16          **WHEREAS,** her late father, Pablo, served as Mayor of Pasay City for
