## BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I MINA'BENTE SIETE NA LIHESLATURAN GUÅHAN:

WHEREAS, the Standing Rules of *I Mina'Bente Siete Na Liheslaturan Guåhan* specifically identified the Guam Youth Congress as an oversight responsibility of the Committee on Youth & Senior Citizens, Federal & Foreign Affairs, Veteran and Military Affairs and Human & Natural Resources; and

WHEREAS, the Standing Rules of *I Mina'Bente Ocho Na Liheslaturan Guåhan* does not specifically identify the Guam Youth Congress, raising a question as to which of the Standing Committees of *I Liheslatura* should have oversight, either the Committee on Criminal Justice, Public Safety, Youth and Public Affairs because of oversight on Youth, or the Committee on General Matters because of oversight on all elected offices; and

WHEREAS, given that the Guam Youth Congress has traditionally been included with the committee that has oversight on Youth, it stands to 7M5 JAN 14 PM 11: 26 48

**RESOLVED**, that the Executive Committee of *I Mina' Bente Ocho Na Liheslaturan Guåhan* on behalf of the people of Guam, shall immediately amend subitem (vii) of Section 17.08, Committee on Criminal Justice, Public Safety, Youth and Public Affairs, of Rule XVII, Committees of *I Liheslaturan Guåhan*, of the current Standing Rules to read as follows:

" (vii) all matters relating to the Guam Youth Congress." and be it further
