

4 **Weilbacher, formerly Kathrina Jonelle Matsumiya Perez),**
5 **Kenye Marie Weilbacher, Ryan Gerard Weilbacher; and**

6 **WHEREAS, Lourdes M. Weilbacher graduated from John F.**
7 **Kennedy High School Class of 1976, and**

8 **WHEREAS, Lourdes M. Weilbacher continued her education**
9 **at the International Business College in 1976-1978; and**

10 **WHEREAS, Lourdes M. Weilbacher worked for former**
11 **Senator Jerry Rivera; and**

12 **WHEREAS, from March 20, 1985 to April 20, 1990 Lourdes M.**
13 **Weilbacher was a Municipal Clerk for the Tamuning-Tumon**
14 **Mayor's Office under the Dungca-Calvo administration; and**

15 **WHEREAS, from April 23, 1990 to April 15, 1996 Lourdes M.**
16 **Weilbacher was the administrative Assistant for the Tamuning-**
17 **Tumon Mayor's Office, again under the Dungca-Calvo**
18 **Administration; and**

1 WHEREAS, on April 15 1996, Lourdes M. Weilbacher
2 tendered her resignation to the Chief Executive Officer of the
3 Mayor's Council; and

4 WHEREAS, in April 16, 1996 Lourdes M. Weilbacher
5 Pursuant to the provisions of §40110 of Title 5, Guam Code
6 Annotated, found on Section 4 of Public Law 22-50 was appointed
7 by then Governor Cart T.C. Gutierrez to fill the unexpired term of
8 the Honorable Teresita Borja; and

9 WHEREAS, Upon her appointment to serve as Vice-Mayor of
10 Tamuning-Tumon on April 16, 1996 Mrs. Lourdes M Weilbacher
11 was ready to serve as Vice Mayor for the people of Tamuning-
12 Tumon; and

13 WHEREAS, on January 6, 1997 Lourdes M. Weilbacher's term
14 expired; and

15 WHEREAS, from January 20, 1998 to October 12, 1999, Loudes
16 M. Weilbacher served as the Municipal Clerk under the Herrero-
17 Duenas Administration; and

18 WHEREAS, Lourdes M. Weilbacher served the Island
19 Community as a member of the American Red Cross (Crusader) for
20 the betterment of our island community and abroad; and

1 WHEREAS, Lourdes M. Weilbacher actively participated in
2 the Guam Little League Baseball and the Guam Amateur Baseball
3 League; and

4 WHEREAS, Lourdes M. Weilbacher's personality traits is best
5 described by her loving children as a Fun-loving woman (was the
6 life of any social gathering) a Candid and resilient, hard working
7 mother not to mention down-to-earth, who would go to any lengths
8 for her family, and most especially her kids; and now, therefore, be
9 it;

10 RESOLVED, that *I Mina'bente Ocho na Liheslaturan Guåhan*
11 is hereby authorized to pay for funeral expenses for the late former
12 Vice-Mayor Lourdes M. Weilbacher and is not to exceed six
13 thousand dollars (\$6,000.00), and be it further

14 RESOLVED, that *I Mina'bente Ocho na Liheslaturan Guåhan*,
15 on behalf of the people of Guam, does hereby recognize the
16 outstanding contributions, and services of the late former Vice
17 Mayor Lourdes M. Weilbacher, and extends humble and sincere
18 condolences to the Weilbacher Family, and be it further

1 **RESOLVED**, that the Speaker and the Legislative Secretary
2 attest to, the adoption hereof and that copies of the same be
3 thereafter transmitted to her children Anthony Joseph Weilbacher,
4 Kenye Marie Weilbacher and Ryan Gerard Weilbacher, to the
5 Mayor's Council of Guam; and to the Honorable Felix P. Camacho,
6 *I Maga'låhen Guåhan.*
