7 become good sportsman and winners; and


8           **WHEREAS**, Mr. David M. Blas has exhibited his intelligence and talents

18 school, and extends a heartfelt, *un dångkolo na si yu'os ma'åse*; and be it further


19           **RESOLVED**, that the Speaker certify, and the Secretary of the
