3 **WHEREAS, Sergeant Jay Tilton, a career NCO who came to Andersen**
4 **Air Force Base, Guam in May 2004, has since unselfishly promoted friendship**
5 **and cultural awareness between the United States Air Force and the people of**

1 Guam and has had an outstanding tour of duty in Guam, where his presence
2 will be sorely missed by friends and associates; and

3 **WHEREAS**, Sergeant Tilton, a Civil Engineer from Ohio who was
4 assigned as Operations Flight Superintendent, 36th Civil Engineer Squadron,
5 has shown deep compassion for the people of Guam by spearheading efforts
6 for Habitat for Humanity home construction; and

7 **WHEREAS**, Sergeant Tilton strengthened the unique partnership with
8 the 254th Civil Engineer Squadron, Guam Air National Guard. He acquired
9 more than one thousand two hundred (1,200) Air National Guard man-days
10 from Headquarters Pacific Air Forces, providing employment for more than
11 eighteen (18) Air National Guard members within the 36th Civil Engineer
12 Squadron. This provided the opportunity for the Guam Air National Guard
13 civil engineers to finish their engineering skills training while completing
14 work orders that support the Andersen community; and

15 **WHEREAS**, Sergeant Tilton served as an evaluator for the Guam
16 Multiple School Unit Junior Reserve Officer Training Corps drill competition,
17 and served as a youth basketball coach, thereby impacting fifteen (15) youths;

19 **WHEREAS**, Sergeant Tilton was a champion of support to Team
20 Andersen's quality of life. He directed the support for the major holiday
21 festivities on Andersen, including, the Rota Walk Holiday Lights Festival, the
22 tree lighting ceremony in Arc Light Park, the annual Tops in Blue
23 performance, as well as the 2004 Air Show. His work force constructed stages,
24 provided utility and participant support, and improved base and community
25 quality of life; and

1 **WHEREAS**, Sergeant Tilton selflessly contributed over one hundred
2 (100) hours of his time in support of people and programs at the Andersen
3 Chapel; now, therefore, be it
