**Relative to recognizing the accomplishments and dedication of the late Honorable Lourdes Manibusan Weilbacher, former Vice Mayor of Tamuning-Tumon, and extending humble and sincere condolences to her family on behalf of *I Liheslaturan Guåhan* and the People of Guam.**

1           **BE IT RESOLVED BY I MINA'BENTE OCHO NA LIHESLATURAN**  
2 **GUÅHAN:**

3           **WHEREAS,** the late Honorable Lourdes Manibusan Weilbacher was  
4 born on January 13, 1958 to the late Jose Adriano Manibusan and the late  
5 Maria Garrido Manibusan both of NCS Dededo (originally Tamuning); and

1           **WHEREAS**, in 1979, the former Lourdes Manibusan married her loving  
2 husband Florencio “Flores” Bernard Weilbacher (deceased) Malem, Kosrae;  
3 and

4           **WHEREAS**, Lourdes M. Weilbacher is survived by her three (3) children  
5 Anthony Joseph Weilbacher, married to Kathrina Jonelle Matsumiya Perez  
6 Weilbacher, Kenye Marie Weilbacher, and Ryan Gerard Weilbacher; and

7           **WHEREAS**, Lourdes M. Weilbacher graduated from John F. Kennedy  
8 High School, Class of 1976; and

9           **WHEREAS**, Lourdes M. Weilbacher continued her education at the  
10 International Business College in 1976-1978; and

11           **WHEREAS**, Lourdes M. Weilbacher worked for former Senator Jerry  
12 Rivera; and

13           **WHEREAS**, from March 20, 1985 to April 20, 1990, Lourdes M.  
14 Weilbacher was a Municipal Clerk for the Tamuning-Tumon Mayor’s Office  
15 under the Dungca-Calvo administration; and

16           **WHEREAS**, from April 23, 1990 to April 15, 1996, Lourdes M.  
17 Weilbacher was the administrative Assistant for the Tamuning-Tumon  
18 Mayor’s Office, again under the Dungca-Calvo Administration; and

19           **WHEREAS**, on April 15, 1996, Lourdes M. Weilbacher, tendered her  
20 resignation to the Chief Executive Officer of the Mayor’s Council; and

21           **WHEREAS**, in April 16, 1996 Lourdes M. Weilbacher, pursuant to the  
22 Provisions of §40110 of Title 5, Guam Code Annotated, was appointed by then  
23 Governor Cart T.C. Gutierrez to fill the unexpired term of the Honorable  
24 Teresita Borja; and

1           **WHEREAS**, upon her appointment, Mrs. Lourdes M. Weilbacher was  
2 ready to serve as Vice Mayor for the people of Tamuning-Tumon; and

3           **WHEREAS**, on January 6, 1997, Lourdes M. Weilbacher's term expired;  
4 and

5           **WHEREAS**, from January 20, 1998 to October 12, 1999, Lourdes M.  
6 Weilbacher served as Municipal Clerk under the Herrero-Duenas  
7 Administration; and

8           **WHEREAS**, Lourdes M. Weilbacher served as a member of the  
9 American Red Cross (Crusader) for the betterment of our island community  
10 and abroad; and

11           **WHEREAS**, Lourdes M. Weilbacher actively participated in Guam Little  
12 League Baseball and the Guam Amateur Baseball League; and

13           **WHEREAS**, Lourdes M. Weilbacher's personality traits are best  
14 described by her loving children as a fun-loving woman who was the life of  
15 any social gathering, a candid and resilient, hard working mother not to  
16 mention down-to-earth, who would go to any lengths for her family, and  
17 most especially her children; now, therefore, be it

18           **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan* is hereby  
19 authorized to pay for funeral expenses for the late former Vice Mayor Lourdes  
20 M. Weilbacher not to exceed Six Thousand Dollars (\$6,000.00); and be it

22           **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan*, does  
23 hereby, on behalf of the people of Guam, recognize the outstanding  
24 contributions and services of the late former Vice Mayor Lourdes Manibusan


1 Weilbacher, and extends humble and sincere condolences to the Weilbacher  
2 Family; and be it further

3 **RESOLVED**, that the Speaker certify, and the Secretary of the  
4 Legislature attest to, the adoption hereof, and that copies of the same be  
5 thereafter transmitted to the children of the late Honorable Lourdes  
6 Manibusan Weilbacher: Anthony Joseph Weilbacher; Kenye Marie  
7 Weilbacher; and Ryan Gerard Weilbacher; to the Mayor's Council of Guam;  
8 and to the Honorable Felix P. Camacho, *I Maga'lahaen Guåhan*.
