3 WHEREAS, the people of Guam acknowledge the pain, suffering and 4 loss sexual assault victims and their family members and friends endure 5 because of the harmful acts of others, with serious public health implications; 6 and 1 WHEREAS, sexual assault victims and sexual assault survivors have 2 suffered from heinous crimes and deserve assistance to help cope with the 3 consequences; and

4 WHEREAS, in order to end sexual assault on our island, we must 5 educate and support the employees and volunteers of community-based 6 organizations and government agencies who provide services to sexual 7 assault victims and survivors; and

8 WHEREAS, our island values the importance of support programs and 9 services to sexual assault victims and survivors who seek to regain self-10 dignity through counseling, medical services, food and transportation; and

11 WHEREAS, the Sexual Assault Coalition, under the direction of the 12 Healing Hearts Crisis Center of the Department of Mental Health and 13 Substance Abuse, has demonstrated how forging collaborative relationships 14 between service organizations and agencies improves the quality of service 15 for persons impacted by sexual violence, and how the rest of the community 16 must work together to speak out and find solutions to sexual violence; and

WHEREAS, the Healing Hearts Crisis Center has been instrumental in addressing sexual assault cases by providing 24-hour hotline services, responding to emergency calls, providing social work and counseling services, comforting victims during medico-legal rape exams, and empowering those impacted by sexual assault to progress toward healing; and

WHEREAS, community-based organizations and government agencies
 advocate for and support sexual assault victims and survivors by providing
 prevention, education, and survivor empowerment information to schools,

churches, civic organizations, as well as law enforcement, medical, mental
 health, education and criminal justice professionals; and

12 **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan* does hereby, 13 on behalf of the people of Guam, further commend the employees and 14 volunteers of community-based organizations and government agencies who 15 provide services and care for sexual assault victims and survivors during 16 "Sexual Assault Awareness Month"; and be it further

17 **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan* does hereby, 18 on behalf of the people of Guam, commend the employees and volunteers of 19 the Healing Hearts Crisis Center of the Department of Mental Health & 20 Substance Abuse and the Sexual Assault Coalition for their efforts to educate 21 the community and prevent sexual assault, and for providing comfort and 22 support to sexual assault victims and survivors; and be it further
