11 and camaraderie; and


12 **WHEREAS**, the Bolinao-Bani Association will welcome Ms. Linda Caasi

18 order; now, therefore, be it


19 **RESOLVED**, that *I Mina' Bente Ocho Na Liheslaturan Guåhan* does hereby,
