12 maintenance of a democratic way of life; and


13 **WHEREAS**, Ms. Roselyn Lou Mitschelen teaches her students about the

21 exceptional service educating our island's children; and be it further


22 **RESOLVED**, that the Speaker certify, and the Secretary of the
