3 **WHEREAS**, Mr. Paul M. Shintaku was appointed by the Governor to
4 assume the position of Deputy General Manager for Jose D. Leon Guerrero

1 Commercial Port on January 13, 2003 and his appointment was confirmed by
2 the Port Board of Directors at their September 4, 2003 meeting; and

3 **WHEREAS**, Mr. Paul Shintaku's first mission was to reverse the
4 Authority's financial trend after nine (9) consecutive years of operating losses;
5 and

6 **WHEREAS**, through his guidance, the Authority reported net earnings
7 of Seven Hundred Seventy-Five Thousand Dollars (\$775,000) in 2003 despite
8 Super Typhoon Ponsongna and the West Coast lockout; and

9 **WHEREAS**, through Mr. Paul Shintaku's leadership, the employees
10 stepped up to the challenge of taking control of the Port's finances and
11 operations and instituted budgetary constraints; and

12 **WHEREAS**, through his outstanding management skills, the Authority
13 was transformed from a dispirited and financially troubled agency to one that
14 realized profits for fiscal years of 2003, 2004 and 2005; and

15 **WHEREAS**, Mr. Paul Shintaku is resigning from his position as Deputy
16 General Manager of the Jose D. Leon Guerrero Commercial Port to assume a
17 more active role as a senior Army Reserve Officer to the Marianas; and

18 **WHEREAS**, Mr. Paul Shintaku is not only a dedicated and hard-
19 working employee but an outstanding Deputy General Manager who
20 motivated the Port employees to strive for excellence; and


21 **WHEREAS**, it is the hope of all that the loss of the employees of the Port
22 will be a gain for the people of Guam since Mr. Paul Shintaku will be devoting
23 his time as a reservist of the United States Armed Forces; now, therefore, be it
