- 3 WHEREAS, Isaac Gallegos was born on December 18, 1984 to Phillip
- 4 and Nely Jean Gallegos of New Mexico and his grandparents, Segundino
- 5 Payas (deceased) and Rosita Finona Payas, are from the village of Agat; and

- 1 WHEREAS, Lance Corporal Isaac Gallegos graduated from Dulce High
- 2 School in 2005 with honors, receiving the Presidential Academics Excellence
- 3 Award and the Marine Corps Academic Excellence Award; and
- 4 WHEREAS, Lance Corporal Issac Gallegos received two (2)
- 5 Congressional appointments to Annapolis, but did not make the final cut, and
- 6 attended one year of college at New Mexico Military Institute where he
- 7 played football, and also attended San Juan College, Associate Arts (AA)
- 8 Liberal Arts; and
- 9 WHEREAS, in May 2005, Issac Gallegos enlisted in the U.S. Marine
- 10 Corps and hoped to eventually attend Officer Candidate School; and
- 11 WHEREAS, Lance Corporal Issac Gallegos is currently serving with the
- 12 3rd Light Armored Reconnaissance Battalion deployed to Iraq in March 2006;
- 13 and
- 14 WHEREAS, after his tour in Iraq was extended in August 2006, Lance
- 15 Corporal Issac Gallegos received serious injuries when his vehicle
- 16 encountered a roadside bomb that destroyed the vehicle and killed five (5) of
- 17 his fellow Marines; and
- 18 WHEREAS, Lance Corporal Issac Gallegos' injuries were the worst of
- 19 the three (3) survivors of the bombing, requiring him to be brought to
- 20 Germany and then back to the United States and hospitalized in Austin,
- 21 Texas, threatening his life and requiring four (4) surgeries in three (3) days;
- 22 now, therefore, be it
- 23 **RESOLVED**, that I Mina' Bente Ocho Na Liheslaturan Guåhan does hereby,
- on behalf of the people of Guam, commend U. S. Marine Lance Corporal Isaac

- Gallegos for his bravery while serving our country and representing the 1
- 2 people of Guam in Iraq; and be it further

- Legislature attest to, the adoption hereof, and that copies of the same be 4
