3 totaling One Hundred Forty-three Million Dollars (\$143,000,000); and


4           **WHEREAS**, the Government of Guam Employees Federal Credit Union

16 and be it further


17           **RESOLVED**, that the Speaker certify, and the Secretary of the
