3 **WHEREAS,** the late Edward M. Calvo remains a much beloved and
4 respected community figure for the many lives he touched through his civic
5 and commercial activities; and

6 **WHEREAS,** the late Edward M. Calvo fell victim to cancer on
7 September 14, 2004; and

1 **WHEREAS**, during his medical treatment off-island the late Edward M.
2 Calvo often expressed his preference and desire to receive treatment on
3 Guam, in the comfort of his family and many friends; and

4 **WHEREAS**, the Edward M. Calvo (EMC) Cancer Foundation was
5 established shortly after the passing of the Foundation's namesake; and,

6 **WHEREAS**, the EMC Cancer Foundation seeks to provide to local
7 cancer patients the comfort of adequate cancer care on Guam, and improve
8 the quality of local cancer care; and

9 **WHEREAS**, in the five (5) months since its creation the EMC Cancer
10 Foundation has already extended assistance to thirteen (13) cancer patients,
11 providing monetary grants to cover expenses including medical and travel
12 expenses, medicine, and treatment; and

13 **WHEREAS**, the EMC Cancer Foundation is raising funds for the
14 establishment of an adequate cancer care facility on Guam; and

15 **WHEREAS**, the EMC Cancer Foundation is hosting a gala benefit
16 dinner and concert on March 4, 2005, to raise awareness of the Foundation's
17 purposes and funds in support of its mission; now, therefore, be it

18 **RESOLVED**, that *I Mina' Bente Ocho Na Liheslaturan Guåhan* does hereby,
19 on behalf of the people of Guam, commend the EMC Cancer Foundation for
20 continuing the legacy of community generosity and caring established by its
21 namesake, the late Edward M. Calvo; and be it further

23 on behalf of the people of Guam, further commend the Edward M. Calvo
24 Cancer Foundation for its efforts to improve the quality of care for local cancer


1 patients, and expand local medical facilities for cancer patients; and be it
