- 4 collective concern on crime victims' rights to participate in judicial processes
- 5 through access to specific information, adequate protection, reasonable
- 6 restitution and to be heard in certain forums; and
- WHEREAS, the people of Guam value many of the important programs
- 8 and services that help crime victims regain self-dignity, obtain safe housing,
- 9 food, transportation, counseling, medical services and support for their
- 10 children; and
- 11 WHEREAS, community and government-based organizations advocate
- 12 for and support crime victims to improve crime victims' rights, providing
- 13 services and treatment, and establishing a more just community through
- 14 entities such as the Office of the Attorney General's Crime Victims' Response
- 15 Unit, the Catholic Social Services ALEE Shelter, the Victim Advocates
- 16 Reaching Out (VARO), the Guam Police Department Victim Assistance Unit,
- 17 Erica's House, Sanctuary, Inc., the Public Defender Service Corporation, the
