**Relative to requesting the United States Congress to amend Section 1421g. of the Organic Act of Guam, to improve health care in Guam.**

1        **BE IT RESOLVED BY I MINA'BENTE OCHO NA LIHESLATURAN**

3        **WHEREAS,** healthcare in Guam requires vast systemic, as well as  
4 material improvements; and

5        **WHEREAS,** Guam Memorial Hospital, in particular, needs  
6 improvement in a large number of areas, including issues of governance; and


1           **WHEREAS**, Section 1421g. of the Organic Act of Guam limits *I*  
2 *Liheslaturan Guåhan's* (the Legislature's) ability to make significant  
3 improvements in the area of Guam's Public Health system; now, therefore, be  
4 it

5           **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan* does hereby,  
6 on behalf of the people of Guam, request that our Washington Delegate, the  
7 Honorable Madeleine Z. Bordallo, introduce legislation into the U.S. Congress  
8 amending Section 1421g. of the Organic Act of Guam, so that the word  
9 "governor" in that Section shall be replaced by the word "government",  
10 giving the people of Guam greater latitude and flexibility to make  
11 improvements in our Public Health system, including our hospital; and be it

13           **RESOLVED**, that the Speaker certify, and the Secretary of the  
14 Legislature attest to, the adoption hereof and that copies of the same be  
15 thereafter transmitted to the Honorable Madeleine Z. Bordallo, Member of  
16 Congress, U. S. House of Representatives; and to the Honorable Felix P.  
17 Camacho, *I Maga'lahaen Guåhan*.
