1        **BE IT RESOLVED BY I MINA'BENTE OCHO NA LIHESLATURAN**  
2 **GUÅHAN:**

3        **WHEREAS**, the Guam Chamber of Commerce established in 1924, has  
4 survived foreign occupations, World War II, numerous typhoons, economic  
5 crisis; and

6        **WHEREAS**, notable businessmen Pedro Martinez, Chester Carl Butler,

1 H.U. Umstad, Baltazar J. Bordallo, William G. Johnston, J.M. Gillespie and  
2 A.H. White, established and chartered the Guam Chamber of Commerce on  
3 April 26, 1924, contributing their time, influence and financial resources to the  
4 chamber organization; and

5 **WHEREAS**, for more than eight (8) decades, the Guam Chamber of  
6 Commerce has served as the catalyst for business opinions and have  
7 represented the business needs on our island; and

8 **WHEREAS**, the Guam Chamber of Commerce has helped numerous  
9 small businesses open their doors, and prosper and grow, thus continuing the  
10 growth of our local economy, and further serving our people; and

11 **WHEREAS**, the Guam Chamber of Commerce currently has a  
12 membership of more than three hundred twenty (320) members and continues  
13 to thrive every year; and

14 **WHEREAS**, the Guam Chamber of Commerce has twenty-eight (28) of  
15 their members celebrating their membership anniversaries of twenty (20)  
16 years to sixty (60) years of membership; and

17 **WHEREAS**, in 1992, the Guam Chamber of Commerce established the  
18 Guam Business Hall of Fame to commemorate Guam's business visionaries;  
19 and

20 **WHEREAS**, among the first inductees to the Guam Business Hall of  
21 Fame was Guam Chamber of Commerce founding members Pedro  
22 Pangelinan Martinez, Kenneth T. Jones, Jr., Jesus Sablan Leon Guerrero,  
23 Governor Joseph Flores, and Eduardo Torres Calvo; and

24 **WHEREAS**, in 1998, the Guam Chamber of Commerce formed the  
25 Armed Forces Committee to promote Guam as a rest and relaxation

1 destination for armed forces in the area and to increase local business  
2 opportunities for contracting with the military on the island; and

3       **WHEREAS**, during the past five (5) years, the Guam Chamber of  
4 Commerce continued its active involvement and support of community  
5 projects to include: the Guam Juvenile Drug Court Program, the Summer  
6 Youth Swimming and Water Safety Program, the annual Christmas Program,  
7 and the Dave J. Santos Scholarship; and

8       **WHEREAS**, this anniversary of the Guam Chamber of Commerce marks  
9 the sixtieth (60<sup>th</sup>) membership anniversary of the Jones & Guerrero Company,

24 Dickerson & Quinn, Ltd., R&C Tours, (Guam), Inc.; now, therefore, be it


25       **RESOLVED**, that *I Mina'Bente Ocho Na Liheslaturan Guåhan* does hereby,
