RELATIVE TO COMMENDING, CONGRATULATING AND EXPRESSING
APPRECIATION TO MRS. JANE SANCHEZ RAPHAEL UPON HER RETIREMENT
AFTER THIRTY-THREE YEARS OF SERVICE TO THE PEOPLE OF GUAM.

1 BE IT RESOLVED BY I MINA' BENTE NUEBI NA LIHESLATURAN GUÅHAN:

2 WHEREAS, Mrs. Jane Sanchez Raphael, from the village of Yigo, was born on
3 September 24, 1953. She grew up as a proud student of the Guam Public School System,
4 earning her High School Diploma from John F. Kennedy High School. On November 28, 1970
5 she married †Billy Cruz Raphael. The couple has been blessed with three (3) children and
6 eleven (11) grandchildren; and

7 WHEREAS, to support her growing family, Mrs. Jane Sanchez Raphael began
8 employment as a General Helper at the Public Utilities Agency of Guam (PUAG) on February
9 17, 1974, just a few years following her marriage; and

10 WHEREAS, through her hard work and dedication, the Management of PUAG
11 recognized her potential as a valuable employee and on November 23, 1975, only a little over a
12 year after being hired, Mrs. Jane Sanchez Raphael earned her first promotion to Clerk I; and

13 WHEREAS, Mrs. Jane Sanchez Raphael maintained her strong work ethic and continued
14 to perform her duties at such a level that earned her a two-step promotion to Clerk III on
15 February 27, 1977; and

16 WHEREAS, her drive to excel did not stop there. Mrs. Jane Sanchez Raphael was
17 further promoted to Clerk Typist III on May 23, 1979. Two and half years later, on February 7,
18 1982, she earned yet another promotion to the position of Customer Service Representative,
19 which she has maintained through the present time; and

1 **WHEREAS**, during her career at Guam Waterworks Authority, which was once PUAG,
2 Mrs. Jane Sanchez Raphael has given thirty-three (33) years of service to the people of Guam.
3 Her decision to maintain her employment with GWA over those three decades allowed her to
4 share the skills and knowledge she developed over the years with the people who she worked
5 with on a daily basis; now, therefore, be it

6 **RESOLVED**, that *I Mina' Bente Nuebi Na Liheslaturan Guåhan* on behalf of *I Liheslaturan*
7 *Guåhan* does hereby congratulate and thank Mrs. Jane Sanchez Raphael for her thirty-three (33)
8 years of service as a Government of Guam employee; now, be it further
