Relative to supporting Taiwan's entry into the World Health Organization.

1 **BE IT RESOLVED BY I LIHESLATURAN GUÅHAN:**

WHEREAS, Ninety-seven years ago on October 10, 1911, the Republic of China was founded. The United States of America and the Republic of China have been friends and allies for many years. Throughout this time the ties of friendship and the commercial interests of the United States of America and the Republic of China have developed into a stronger partnership; and

WHEREAS, the freedom and democracy enjoyed by the people of the 7 8 Republic of China (Taiwan) are clearly demonstrated in the progress and growth of the economy of this great country. This year the Republic of China (Taiwan) will 9 observe the 97th Anniversary of the Founding on October 10, 2008. In furthering its 10 11 commitment to freedom and democracy Taiwan continues to seek representation in 12 international organizations and the people and the government of Guam support their 13 efforts and entry into the United Nations and the World Health Organization. Good 14 health is important to every citizen of the world and access to the highest standards of 15 health information and services is necessary to improve the public health; and

1 WHEREAS, the preamble of the World Health Organization (WHO) 2 Constitution states that 'the enjoyment of the highest attainable standard of health is 3 one of the fundamental rights of every human being without distinction of race, 4 religion, political belief, economic or social condition. Taiwan and its twenty-three million five hundred thousand (23,500,000) people wish to join the World Health 5 6 Organization (WHO) as a member. Because health and disease have no borders, it is 7 in the best interest of the human condition that Taiwan be afforded membership in the 8 WHO in order to benefit from information regarding the prevention, monitoring and cure of epidemic diseases, prevention of terrorist bio-chemical attacks, and 9 10 discussions of global health policies; and

WHEREAS, Taiwan's achievements in the field of health are substantial, including one of the highest life expectancy levels in Asia; maternal and infant mortality rates comparable to those of western countries; the eradication of such infectious diseases as cholera, smallpox and the plague; and being the first nation to eradicate polio and provide children with Hepatitis B vaccinations; and

16 WHEREAS, direct and unobstructed participation in international health 17 cooperation forums and programs is beneficial for all parts of the world, especially 18 with today's greater potential for the cross-border spread of various infectious diseases 19 such as the human immunodeficiency virus (HIV), tuberculosis, and malaria. Taiwan's 20 population of 23,500,000 people is greater than that of three-fourths of the member states already in the World Health Organization (WHO). Taiwan's achievements in the 21 22 field of health are substantial, including one of the highest life expectancy levels in 23 Asia, maternal and infant mortality rates comparable to those of western countries, the 24 eradication of such infectious diseases as cholera, smallpox, and the plague, and the 25 first to eradicate polio and provide children with hepatitis B vaccinations; and

WHEREAS, the United States Centers for Disease Control and Prevention and its Taiwan counterpart agencies have enjoyed close collaboration on a wide range of public health issues. In recent years Taiwan has expressed a willingness to assist
 financially and technically in international aid and health activities supported by the
 WHO; and

WHEREAS, on January 14, 2001, an earthquake, registering between 7.6 and
7.9 on the Richter scale, struck El Salvador. In response, the Taiwanese Government
sent 2 rescue teams, consisting of 90 individuals specializing in firefighting, medicine,
and civil engineering. The Taiwanese Ministry of Foreign Affairs also donated
\$200,000 in relief aid to the Salvadoran Government; and

9 **WHEREAS**, the World Health Assembly has allowed observers to participate 10 in the activities of the organization, including the Palestine Liberation Organization in 11 1974, the Order of Malta, and the Holy See in the early 1950s. The United States, in the 1994 Taiwan Policy Review, declared its intention to support Taiwan's 12 13 participation in appropriate international organizations. U.S. Public Law 106-137 required the Secretary of State to submit a report to the Congress on efforts by the 14 15 executive branch to support Taiwan's participation in international organizations, in 16 particular the WHO; and be it further

17 **RESOLVED**, that I Mina 'Bente Nuebi na Liheslaturan Guåhan, on behalf of 18 the people of Guam, in light of all benefits that Taiwan's participation in the WHO can 19 bring to the state of health not only in Taiwan, but also regionally and globally, Taiwan and its 23,500,000 people should have appropriate and meaningful 20 participation in the WHO. As noted in his speech made in the World Medical 21 22 Association on May 14, 2002, Secretary of Health and Human Services Tommy Thompson announced America's work for a healthy world cuts across political lines. 23 24 According to Secretary Thompson, the U.S. government supports Taiwan's efforts to 25 gain observership status at the World Health Assembly; and be it further

RESOLVED, that *I Mina'Bente Nuebi na Liheslaturan Guåhan*, on behalf of the people of Guam, does hereby express its support for the people of Taiwan, that they deserve the same level of public health as citizens of every nation on earth, and
 that we support them in their efforts to achieve its objective to become a member of
 WHO; and be further

4 **RESOLVED**, that the Speaker certify to and the Secretary of the Legislature 5 attest to, the adoption hereof and that copies of the same be thereafter transmitted to 6 the Honorable Margaret Chan, Director General, World Health Organization; to the 7 Honorable George W. Bush, President of the United States of America; to the 8 Honorable Condoleeza Rice, Secretary of State, United States of America; to the 9 Honorable Mike Leavitt, Secretary of Health and Human Services, United States of 10 America; to the Honorable Chen Shui-bian, President, Republic of China (Taiwan); to the Honorable Huang Chih-fang, Minister, Ministry of Foreign Affairs, Republic of 11 12 China (Taiwan); to the Honorable Sheng-Mou Hou, MD, Ph.D., MPH, Minister, 13 Department of Health, Republic of China (Taiwan); to the Honorable James C.Y. 14 Chin, Director General, Taipei Economic and Cultural Office in Guam; to the 15 Honorable Ban ki-moon, Secretary General of the United Nations; to the Honorable 16 Madeleine Z. Bordallo, Guam's Delegate to the United States Congress and to the 17 Honorable Felix P. Camacho, I Maga'lahen Guåhan.
