

Relative to recognizing and commending Mr. Peter Flores Aguon on the occasion of his retirement after Thirty One years of active government service to the government of Guam in government finance.

3 **WHEREAS**, Mr. Peter Flores Aguon first started his employment with the
4 government of Guam in 1977 at the Bureau of Budget and Management Research,
5 setting the tone for a long career in financial management of government finances for
6 many years to come; and

7 **WHEREAS**, starting in 1982, Mr. Aguon worked for the Legislature's
8 Committee on Ways and Means under the direction of former Speaker and Senator
9 Joe T. San Agustin, analyzing and preparing government-wide budget documents for
10 the annual budgets of the government of Guam; and

11 **WHEREAS**, after a number of years at the Legislature, in November 1985 Mr.
12 Aguon began working for the Guam Community College as Payroll Coordinator, later
13 transferring to Controller of the College February 27, 1989; and

1 **WHEREAS**, Mr. Aguon started working at the Department of Administration
2 on April 9, 1990, where he continued working until his retirement on April 25, 2008;
3 and

4 **WHEREAS**, Peter Aguon is a hard-working and friendly person, very
5 dedicated and responsible, and the government of Guam has benefited greatly from
6 his good work from 1977 to 2007 in the various departments of the government
7 involved with finance; and

8 **WHEREAS**, Mr. Aguon earned a number of commendations from past
9 government directors and clients, thanking him specially for his help in solving
10 problems, and he also received commendations from various governors for his
11 unselfish volunteer work helping with a variety of government sponsored programs,
12 conferences, and off island official visitors; and

13 **WHEREAS**, Mr. Aguon was a strong supporter of the Association of
14 Government Accountants, as well as being involved at the local level as a teacher for
15 CCD classes at his parish church; and

16 **WHEREAS**, Mr. Aguon was noted for his reliability and hard work and will
17 be missed in the Department of Administration especially, where he ended his long
18 career; now, therefore, be it

19 **RESOLVED**, that *I Mina' Bente Nuebi Na Liheslaturan Guåhan* does hereby,
20 on behalf of the people of Guam, recognize and commend Mr. Peter Flores Aguon for
21 his long and devoted career on the occasion of his retirement from the government of
