Relative to recognizing and congratulating Continental Micronesia, Inc. on the occasion of its fortieth (40th) anniversary celebration of servicing Guam and the region, and to commending the Continental staff, management, and Board of Directors for their diligent and dedicated work, and for their many contributions to our island on this auspicious and historic occasion.

1 BE IT RESOLVED BY I MINA'BENTE NUEBI NA LIHESLATURAN GUÅHAN:

- WHEREAS, in 1968, Continental Micronesia Inc, was rooted on Guam as
- 3 Air Micronesia, but was known throughout the region as "Air Mike", and
- 4 inaugurated flights for Saipan-Honolulu with seven island stops in between; and
- 5 WHEREAS, Air Micronesia became an international airline in 1977 and
- 6 inaugurated its Guam-Manila service in 1982, and service to Brisbane and
- 7 Sydney, Australia in 1989, and
- 8 WHEREAS, in 1990, Air Micronesia augmented its fleet with DC-10 and
- 9 B-727 aircraft and added service to Sapporo and Sendai, Japan, Taipei, Taiwan
- 10 and Seoul, Korea; and
- 11 WHEREAS, Air Micronesia began its service to Cebu, Philippines, while
- adding Hong Kong to its list of Asia destinations in 1991; and
- 13 WHEREAS, in 1992, Continental Air Micronesia received certification as
- stand-alone Part 121 carrier Continental Micronesia Inc. (CMI), a leading regional
- 15 carrier for Asia and the Pacific; and
- 16 WHEREAS, Continental Micronesia celebrated its 25th Anniversary in
- 17 1993 by extending long-range wide-body service across the Pacific with B-747s
- 18 operating on CMI Routes; and

1 WHEREAS, Continental Micronesia became the first airline in the world 2 to be equipped and certified with GPS long-range equipment on a B-727 in 1996; 3 as well, the airline inaugurated a cooperative cargo freighter operation with 4 DHL, flying six (6) B-727 freighters, increasing the fleet to fifteen (15) aircraft 5 hubbing from a crew base in Manila to Kuala Lumpur, Singapore, Seoul, Taipei 6 and Hong Kong, while CAL 757 aircraft began operating from a Guam crew base 7 on CMI routes; and 8 WHEREAS, Continental Micronesia displayed its resolve and 9 commitment to the island when it resumed flight service just three (3) days 10 following the destructive visit of Super Typhoon Paka in 1997 and opened its 11 new world-class President's Club in Guam; and 12 WHEREAS, in 1998, Continental Micronesia added the destinations of 13 Niigata and Okyama in Japan; Cairns, Australia and Noumea, New Caledonia; 14 and 15 WHEREAS, in addition to providing air service to and from Guam and 16 Micronesia, Continental Micronesia has flown many missions in the name of 17 humanity, i.e. in 1994, the airline ferried two thousand (2,000) Kurdish refugees to 18 the United States mainland via Guam; and in 1995, Air Mike few five (5) B-727s 19 loaded with WWII veterans to Iwo Jima to commemorate the 50th Anniversary of 20 the historic battle; and 21 WHEREAS, WHEREAS, in 1999, the CMI-DHL freighter venture comes to 22 an end, and Continental Airlines B-737-800 aircraft began operating on 23 Continental Micronesia routes and the phase-out of the familiar B-727s began; 24 and 25 WHEREAS, by 2000, the last Continental Micronesia B-727 was retired 26 from service and the following year a Continental Micronesia B-737 crew flew a 27 mission to rescue a U.S. Navy P-3 crew after release by the Chinese captors 28 following a mid-air collision with a Chinese fighter jet, forcing the Navy 29 surveillance aircraft to make an emergency landing on the island of Hainan; and

1 WHEREAS, in 2001, Continental Micronesia replaced their DC-10s with 2 new 767 aircraft, and the following year ten (10) Continental Micronesia B-737-3 800 aircraft were officially added to the CMI operating fleet; and 4 WHEREAS, despite the world's difficult economic climate and downturn 5 in the challenges that come with a global economy, the Iraq war and other 6 calamities, Continental Micronesia today proudly celebrates its fortieth (40th) 7 year of service to Guam and Micronesia, the airline continues to show its 8 dedication and confidence in the future growth and prosperity of the region; and 9 WHEREAS, Continental Micronesia, Inc. is the island's largest private-10 sector employer with over 1,500 people and operates 236 departures each week 11 between 23 cities; and 12 WHEREAS, over the years Continental Micronesia, Inc. has donated both 13 cash and in-kind assistance: e.g. nearly \$300,000 for super typhoon Pongsona 14 relief including: a \$10,000 donation to the American Red Cross; \$12,000 in travel 15 assistance for PNI linemen; \$151,000 in travel assistance for 130 travel agents and 16 media for the Guam Visitor's Bureau's Super Fam program; and \$68,000 for its 17 employee assistance program; and 18 WHEREAS, Continental Micronesia, Inc. provides service to 25 Asia-19 Pacific destinations in 10 countries and operates 236 departures each week 20 between 23 cities from its hub in Guam, as well as connections to the U.S. 21 mainland via Narita and Honolulu; and 22 WHEREAS, Continental Micronesia, Inc. flies to and from the following 23 airports: in Guam, the Antonio B. Won Pat International Air Terminal, in the 24 Northern Mariana Islands, the Saipan International Airports; in Micronesia, the 25 Federated States, the Chuuk International, Kosrae International, Pohnpei 26 International; and Yap International Airports; and in Palau, the Koror, Palau 27 International Airport; in Australia, Cairns International Airport; Southeast Asia, 28 in Manila, Philippines the Ninoy Aquino International Airport, in Denpasae, 29 Indonesia, Ngurah Rai Airport; in East Asia, China, the Hong Kong International 30 Airport; in Japan, Hiroshima, Fukuoka, Nagoya, Chubu International, Niigata,

1	Okayama, Sapporo, New Chitose, Sendai, and the Tokyo, Narita International
2	Airports and in North America, Hawaii, the Honolulu International Airport; now
