3 **WHEREAS**, Yeoman Harold D. Kirk, Jr. enlisted in the United States Navy on
4 August 23rd 1985; and

5 **WHEREAS**, Yeoman Harold D. Kirk, Jr. served his country at many duty
6 stations and aboard many distinguished naval vessels including the USS Guam (LPH-
7 9); the USS Fortify (MSO 449); the USS Adroit (MSO 509); and the USS Bolder
8 (LST 1190); and

9 **WHEREAS**, Yeoman Harold D. Kirk, Jr. has received numerous honors and
10 awards including:

- 11 The Navy and Marine Corps Achievement Medal (four awards),
- 12 The Navy Meritorious Unit Commendation Ribbon,
- 13 The Navy Battle "E" Ribbon, the Navy Good Conduct Medal (five awards),
- 14 The Global War On Terrorism Services Medal; and

15 **WHEREAS**, Yeoman Harold D. Kirk, Jr. also received
16 The Naval Reserve Meritorious Service Medal;
