3 **WHEREAS**, Yellow Pages Ink is celebrating their Twentieth Anniversary
4 of publishing their telephone book on Guam; and

5 **WHEREAS**, in 1990, Yellow Pages Ink was contracted by the Guam
6 Telephone Authority to publish the GTA Phone Book; and

7 **WHEREAS**, by 1993, Yellow Pages Ink became Guam's first privately
8 owned phone directory and launched the 1993 Guam Phone Book; and

9 **WHEREAS**, Yellow Pages Ink recognized the need to service the many
10 needs of the region so they added a Saipan business section to the 1998 Guam
11 Phone Book; and

12 **WHEREAS**, by 2002, they launched their highly successful online web
13 directory, www.guamphonebook.com, which now has over 2.5 Million page views
14 per year and is considered to be one of the most visited directory sites in the world;
15 and

16 **WHEREAS**, in 2007, PTI Pacifica Inc. purchased both the Guam Phone
17 book and the CNMI Phone Book from the Holmes Management Company; and

1 **WHEREAS**, Yellow Pages Ink printed 100,000 phone books in 2008 that
2 were distributed on Guam and the CNMI; and

3 **WHEREAS**, Yellow Pages Ink has further expanded their operations by
4 offering the directory for mobile phones with immediate access to local numbers at
5 www.guamphonebook.com. The Wireless Access Protocol (WAP) provides a
6 simple text-based interface and “Dial from Directory” functionality that allows
7 cellular phone users an easy way to place calls directly from the listings; now
8 therefore be it

9 **RESOLVED**, that *I Mina’Bente Nuebi Na Liheslaturan Guahan* does
10 hereby, on behalf of the people of Guam commend and congratulate the Yellow
11 Pages Ink, PTI Pacifica Inc. and Citadel Holdings, Inc. on the Twentieth
