BE IT RESOLVED BY I MINA'BENTE NUEBI NA LIHESLATURAN 1 2 **GUÅHAN:** WHEREAS, Yellow Pages Ink is celebrating their Twentieth Anniversary 3 4 of publishing their telephone book on Guam; and WHEREAS, in 1990, Yellow Pages Ink was contracted by the Guam 5 6 Telephone Authority to publish the GTA Phone Book; and WHEREAS, by 1993, Yellow Pages Ink became Guam's first privately 7 owned phone directory and launched the 1993 Guam Phone Book; and 8 9 WHEREAS, Yellow Pages Ink recognized the need to service the many needs of the region so they added a Saipan business section to the 1998 Guam 10 Phone Book; and 11 WHEREAS, by 2002, they launched their highly successful online web 12 13 directory, www.guamphonebook.com, which now has over 2.5 Million page views per year and is considered to be one of the most visited directory sites in the world; 14 and 15 16 WHEREAS, in 2007, PTI Pacifica Inc. purchased both the Guam Phone

book and the CNMI Phone Book from the Holmes Management Company; and

WHEREAS, Yellow Pages Ink printed 100,000 phone books in 2008 that 1 2 were distributed on Guam and the CNMI; and 3 WHEREAS, Yellow Pages Ink has further expanded their operations by offering the directory for mobile phones with immediate access to local numbers at 4 www.guamphonebook.com.
