

4 WHEREAS, Citigroup Guam, also referred to as Citi Guam, first
5 opened its doors on December 1967. Today, it services a consumer and
6 corporate base of more than twenty thousand individual and business
7 accounts with over 100 employees proudly serving their local community
8 every day; and

9 WHEREAS, Citi Guam not only provides financial services, but also
10 fosters and participates in community service initiatives through the
11 Citigroup Global Volunteer Program, where its employees make a
12 difference in our local community by expanding on its tradition of
13 volunteerism; and

1 **WHEREAS**, the Citi Foundation supports Guam’s local community
2 needs through grants towards improving education, financial literacy and
3 community development; and

4 **WHEREAS**, by working with local civic organizations, Citi Guam
5 employee volunteers and the Citi Foundation have contributed to
6 improving the quality of life as a result of leading by example; and

7 **WHEREAS**, on November 18, 2006, on the 1st Annual Citigroup
8 Global Community Day, Citi Guam employees hosted and served a special
9 Thanksgiving feast to patients, their families, and staff of Guam Memorial
10 Hospital’s Skilled Nursing Unit in Barrigada; while another group of Citi
11 Guam employees helped pack Food Boxes at the Salvation Army Guam
12 Chapter’s warehouse for their annual Food Drive; and at which Citi Guam
13 employees donated 800 cereal boxes to feed 800 needy families ; and

14 **WHEREAS**, Citi Guam received accolades from Big Brothers Big
15 Sisters of Guam and received the Distinguished Service Award for their
16 exemplary role in proactively engaging its employees to take time off from
17 work to assist in community services and for being the first in the business
18 community to adopt a school and have the largest number of volunteers;
19 and a Citi Guam employee, Ms. Grace Gagaring received the 2007 Mentor
20 of the Year award; and

21 **WHEREAS**, since the inception of the National “Teach Children to
22 Save Day” and the “Get Smart About Credit Day”, a program sponsored
23 by the American Bankers Association Foundation to teach children and

1 youth about the financial facts of life; Citi Guam employees take time off
2 from their work schedules and become teachers; Citigroup has been active
3 in these initiative and has taught over 1,700 elementary school students
4 and over 326 high school students on Guam. This year, 2007, Citi Guam
5 employee volunteers used the Citigroup Financial Education Curriculum
6 for the first time, to teach over 750 students at Price Elementary School, FQ
7 Sanchez Elementary School, Merizo Elementary School and Marcial A.
8 Sablan Elementary School during 'Teach Children to Save Day', and

9 **WHEREAS**, since 1998, Citi Guam and Citi Foundation have
10 contributed more than Five Hundred Thousand Dollars and countless
11 hours to the improvement of our local communities. Recipients of Citi
12 Guam's generosity include: Excellence in Teaching Foundation, the
13 University of Guam's Small Business Development Center, KGTF (Channel
14 12) Public Television, Sanctuary, Inc., Big Brothers Big Sisters of Guam,
15 Inarajan Elementary School, Junior Achievement of Guam, the American
16 Red Cross, Dededo Senior Citizens Center, the Nieves M. Flores Public
17 Library in *Hagatña*; now, therefore, be it resolved

18 **RESOLVED**, that *I Mina'Bente Nuebi Na Liheslaturan Guåhan* does
19 hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam
20 commend and express our heartfelt *Un Dangkolo Na Si Yu'us Ma'ase* to Citi
