RELATIVE TO EXTENDING A SPECIAL RECOGNITION AND CONGRATULATIONS TO MONSIGNOR FATHER DAVID I. QUITUGUA ON HIS FOURTY-THIRD (43RD) ANNIVERSARY OF ORDINATION TO THE PRIESTHOOD IN SERVICE TO GOD AND OUR PEOPLE, AND ON THE OCCASION OF HIS SEVENTY-FIRST (71ST) BIRTHDAY CELEBRATION, IN ACKNOWLEDGING HIS LIFETIME DEDICATION, FAITHFULNESS, AND DISTINGUISHED SERVICE TO THE PEOPLE OF GUAM.

- 3 WHEREAS, Monsignor Father David I. Quitugua was born to Ignacio
- 4 Perez Quitugua and Rosa Santos Arceo Quitugua on February 26, 1936 in the
- 5 Village of Asan, Guam; and
- 6 WHEREAS, Monsignor Father David I. Quitugua's religious vocation
- 7 was fostered at a bright young age by Father Alvin, OFM Cap., while serving
- 8 as an alter server and attending St. Francis School in Yona; and
- 9 WHEREAS, Monsignor Father David I. Quitugua, after graduating in
- 10 1951, attended the Father Duenas Minor Seminary and was awarded a
- 11 scholarship by Cardinal Cushing of Boston to attend St. John's Major
- 12 Seminary in Brighton, Massachusetts; and whereupon completion of his

- 1 religious studies returned home to Guam and was ordained a priest on
- 2 February 11, 1964 by the late Bishop Apollinaris Baumgartner, First Ordinary
- 3 Bishop of Hagatna; and,
- 4 WHEREAS, Monsignor Father David I. Quitugua was first assigned at
- 5 the Hagatna Cathedral as an assistant to then MSgr. Felixberto C. Flores while
- 6 simultaneously serving as the Priest-In-Charge at the Immaculate Heart of
- 7 Mary Church in Toto, Guam; and between 1965 and 1969, Monsignor
- 8 Quitugua was assigned to St. Anthony and St. Victor Church in Tamuning
- 9 assisting Father Vicente Martinez, and further served as the Chaplain at Guam
- 10 Memorial Hospital and Pastor at St. Williams parish in Tumon; and,
- 11 WHEREAS, Monsignor Father David I. Quitugua served as a member
- 12 of the Juvenile Justice Advisory Committee during which time he taught at
- 13 the Academy of Our Lady of Guam and Father Duenas Memorial High School
- 14 while taking graduate courses in Social Sciences and Secondary Education at
- 15 the University of Guam where in 1969, he became one of the first local
- 16 students to earn a Masters Degree; and,
- 17 WHEREAS, upon graduation from the University of Guam, Monsignor
- 18 Father David I. Quitugua further pursued his post-graduate degree at the
- 19 Catholic University of America, Washington, D.C. in Sociology; and upon his
- 20 return to Guam, he worked full-time at the Department of Public Health and
- 21 Social Services and as a part-time instructor on Social Programs at the
- 22 University of Guam, all while serving as Pastor of the Nuestra Senora de las
- 23 Aguas Church in Mongmong, Guam; and,

1 **WHEREAS**, Monsignor Father David Quitugua was assigned in May of 2 1975, by the late Archbishop Felixberto C. Flores to supervise the resettlement 3 program for thousands of Vietnamese refugees on Guam who were homeless 4 and jobless for which he was presented a unique recognition at the United 5 States Catholic Conference with the "Distinguished Humanitarian Award"; 6 and in 1985 he was selected as the "Social Worker of the Year" in Guam and 7 the following year further recognized by the Pacific Daily News as one of the 8 "Ten Who Made A Difference"; and 9 WHEREAS, in an effort to respond to the social needs of the island 10 community, Monsignor Father David I. Quitugua founded the Catholic Social 11 Services in 1977, and served as its first Director, while assisting Bishop Tomas 12 Camacho in establishing the Catholic Social Services in the Diocese of Chalan 13 Kanoa, Saipan; and continues to serve as a member of both the Board of

many years further served as a member of the Archdiocesan Consultors under the late Archbishop Felixberto C. Flores; and, WHEREAS, in the late 1970's Monsignor Father David I. Quitugua, as

executor of the estate of Tan Rosa Flores, was instrumental in having a piece of land in Barrigada Heights donated to the Archdiocese which later through the request of the late Archbishop Felixberto Flores was given to the Dominican Sisters to build the Saint Dominic's Home for the Elderly in Barrigada Heights; and

- 1 WHEREAS, in spite of his active schedule, Monsignor Father David I.
- 2 Quitugua acquired a second Masters Degree in May, 1992, from Marquette
- 3 University in Wisconsin in the field of communications; and,
- 4 WHEREAS, in September 1993 Monsignor Father David I. Quitugua
- 5 was assigned as the Pastor of San Juan Bautista Church in Ordot, whereupon
- 6 through his leadership he spearheaded the construction of a catechetical
- 7 building which was completed in 1996, and the development of a Prayer
- 8 Garden for its parishioners; and,
- 9 WHEREAS, Monsignor Father David I. Quitugua was chosen by Latte
- 10 Magazine in 1996 as the "Islander of the Year" in recognition of his
- 11 accomplishments and contributions to the entire island of Guam; and
- WHEREAS, Monsignor Father David I. Quitugua, as a reflection of his
- 13 lifetime dedication and commitment to the spiritual and social needs of the
- 14 community of Guam, and for his service to the people of God in the Catholic
- 15 Church, was formally invested with the highest honor bestowed to man by
- 16 the Holy Father, Pope Benedict XVI, to be henceforth known as Monsignor
- 17 Father David I. Quitugua; and,
- 18 WHEREAS, Monsignor Father David I. Quitugua will be celebrating
- 19 his Forty Third (43rd) Anniversary of Ordination into the priesthood and his
- 20 Seventy First (71st) Birthday in a special gathering of family, friends, and
- 21 parishioners on Sunday February 25, 2007; now, therefore, be it

- 24 a special recognition and congratulations to Monsignor Father David I.
