Relative to recognizing the accomplishments of the Guam Chapter 4837, AARP, Inc., established in 1984, recognized as a charter member of the National AARP in 1994 and to extend congratulate them during the second annual AARP Month, September 2007.

1 BE IT RESOLVED BY I MINA'BENTE NUEBI NA LIHESLATURAN 2 GUÅHAN:

3 WHEREAS, Dr. Ethel Percy Andrus and a group of founding directors 4 were members of the National Retired Teacher's Association incorporated 5 AARP on July 1, 1958 in Washington, D.C., then known as the American 6 Association of Retired Persons established as a national organization 7 representing the interests of older Americans; and

8 WHEREAS, Dr. Andrus, the Association's first president, approved the application for recognition of the first AARP chapter in Youngstown, Arizona 9 10 in September 1960 with 100 chapters formed by the end of 1961. The Guam Chapter 4837 organized in 1984 and chartered in 1994. Nationally AARP 11 12 comprises over 39 million members with more than 2,900 AARP chapters; and 13 WHEREAS, "To serve and not to be served" is the AARP motto whose Chapter Bylaws, stress community service, an active and useful life, self-14 actualization and development and a commitment to the ideals of AARP; and 15

1 WHEREAS, the chapter's mission is to represent AARP at the local 2 level, providing a link between members, communities and the Association's 3 programs and services who leadership and commitment to volunteerism is an 4 invaluable resource in strengthening the Association and making 5 communities better places to live and work for all people; and

6 WHEREAS, the chapter's goals and objectives set across a range of 7 functions include community service, leadership, communication, 8 recruitment, fellowship, advocacy and education.

9 WHEREAS, the role of the Chapters is a legal, chartered entity of the 10 Association, a face and heart for AARP in the local community best expressed 11 in the words of the Association's founder, Dr. Ethel Percy Andrus: "AARP has 12 promoted the initiation and development of local volunteer chapters...for those 13 members who favor the goals of individual growth and service to self, to fellow 14 members and to the community in general," and

WHEREAS, AARP began to standardize the various operating rules and procedures for its chapters in the mid1960's and in 1965 the AARP Board of Directors developed the *AARP Chapter Bylaws*, an important step in unifying the young organization into a viable national Association; and

WHEREAS, today's AARP's dynamic force would not have been attained without its "three great goals" and the chapters' participation support. The "three great goals" identified by Mr. Bill Novelli, AARP Executive Director and Chief Executive Officer, for the Association, its units and leaders are: **1.** To be the most successful and acknowledged organization in America for positive social change; **2**) To deliver on our promise to each member: to help them make their own choices, reach their

goals and dreams, and make the most of life after 50; and 3) AARP will be 1 world leader in global aging; and 2

WHEREAS, AARP continues to adapt and grow as an organization built 3 on a history of understanding, representing and meeting the needs, shaping 4 and enriching the experience of aging for each member, for society at large 5 and as a direct link to the local community, AARP chapters remain well 6 7 positioned to play a vital role in the Association's ongoing success; and

8 WHEREAS, as AARP has grown, so have opportunities for service within the Association. AARP chapters are now part of an extensive network 9 or programs and activities conducted primarily by members and volunteers at 10 the local, community and state levels; and 11

12 WHEREAS, Guam Chapter 4837, AARP, Inc. is the recipient of the 2007 13 Annual AARP Chapter Community Service Award for projects initiated in 14 2006 including the proclamation of September by I Maga'lahen Guåhan as 15 AARP Chapter Month with Mr. Mark Chapman, Associate Director of AARP Western Region, as keynote speaker during their banquet; and 16

17 WHEREAS, the Chapter sponsored and invited Republican and 18 Democratic Party gubernatorial and lieutenant governor candidates to a 19 gubernatorial debate during the 2006 campaign period; and

20 WHEREAS, Mr. Vinancio Atalig, current Chapter President, was 21 instrumental in successfully bringing the AARP Medicare Supplemental Plan 1in 2003 and in July of 2007, the AARP Life Insurance Plan available to Guam 22 Chapter 4837, AARP, Inc. members; and 23
