Relative to commending, congratulating and expressing appreciation to Mrs. Jane Sanchez Raphael upon her retirement after thirty-three (33) years of service to the people of Guam.

1 **BE IT RESOLVED BY *I MINA'BENTE NUEBI NA LIHESLATURAN***
2 ***GUÅHAN*:**

3 **WHEREAS**, Mrs. Jane Sanchez Raphael, from the village of Yigo, was
4 born on September 24, 1953. She grew up as a proud student of the Guam
5 Public School System, earning her High School Diploma from John F.
6 Kennedy High School. On November 28, 1970 she married 'Billy Cruz
7 Raphael. The couple has been blessed with three (3) children and eleven (11)
8 grandchildren; and

1 **WHEREAS**, to support her growing family, Mrs. Jane Sanchez Raphael
2 began employment as a General Helper at the Public Utilities Agency of
3 Guam (PUAG) on February 17, 1974, just a few years following her marriage;
4 and

5 **WHEREAS**, through her hard work and dedication, the management of
6 PUAG recognized her potential as a valuable employee and on November 23,
7 1975, only a little over a year after being hired, Mrs. Jane Sanchez Raphael
8 earned her first promotion to Clerk I; and

9 **WHEREAS**, Mrs. Jane Sanchez Raphael maintained her strong work
10 ethic and she continued to perform her duties at such a high level that it
11 earned her a two-step promotion to Clerk III on February 27, 1977; and

12 **WHEREAS**, her drive to excel did not stop there as Mrs. Jane Sanchez
13 Raphael was further promoted to Clerk Typist III on May 23, 1979. Two and
14 half (2 ½) years later, on February 7, 1982, she earned another promotion to
15 the position of Customer Service Representative, which she has maintained
16 through the present time; and

17 **WHEREAS**, during her career at the Guam Waterworks Authority,
18 formerly PUAG, Mrs. Jane Sanchez Raphael has given thirty-three (33) years
19 of service to the people of Guam. Her decision to maintain her employment
20 with GWA over those three (3) decades allowed her to share the skills and
21 knowledge she developed over the years with the people she worked with on
22 a daily basis; now, therefore, be it

24 hereby, on behalf of the people of Guam, congratulate and thank Mrs. Jane


1 Sanchez Raphael for her thirty-three (33) years of service as a Government of
