WHEREAS, the Senate of the Seventh (7th) Olbiil Era Kelulau has
informed the people of Guam of the passing of the Honorable Johnny Reklai,

President of the Senate on Sunday, March 11, 2007 at the age of fifty-eight
 (58) years; and

3 WHEREAS, Senate President Johnny Reklai was born on July 1, 1948, to 4 the late Reklai Baul of the State of Ngarchelong and Remurang Reklai of the 5 State of Ngaraard. He attended Koror Elementary School, graduated from 6 Palau High School, and attended the University of Guam. He is survived by 7 his wife Loretta Wong Reklai, children, and numerous brothers and sisters; 8 and

9 WHEREAS, Senate President Reklai was one of Belau's most senior
10 politicians, beginning in 1979 when he was selected as a member of the First
11 Constitutional Convention of the Republic of Palau, representing the State of
12 Ngarchelong. He subsequently served in the House of Delegates representing
13 his home state of Ngarchelong in the First, Second, and Third Olbiil Era
14 Kelulau. Senate President Reklai was elected as a Senator in the Fourth (4th),
15 Fifth (5th), Sixth (6th) and Seventh (7th) Olbiil Era Kelulau; and

16 WHEREAS, a successful private businessman, Senator Reklai was the 17 President of Republic Express Inc, JRCO Family Finance, Ketund Corp., Sun 18 Dancer, JRCO/Ice Express, and Farm Corp. He was also the Vice President of 19 Palau Shipping and Palau Horizon. Senator Reklai was also a shareholder 20 and chaired the Board of Directors of Pacific Savings Bank; a Member of the 21 Board of Directors of Western Caroline Trading Company; United Micronesia 22 Development Association; and a member of the Chamber of Commerce; now, therefore, be it 23
