3 **WHEREAS, Mr. Peter Flores Aguon first started his employment with**
4 **the government of Guam in 1977, at the Bureau of Budget and Management**

1 Research, setting the tone for a long career in financial management of
2 government finances for many years to come; and

3 **WHEREAS**, starting in 1982, Mr. Aguon worked for the Legislature's
4 Committee on Ways and Means under the direction of former Speaker and
5 Senator Joe T. San Agustin, analyzing and preparing government-wide
6 budget documents for the annual budgets of the government of Guam; and

7 **WHEREAS**, after a number of years at the Legislature, in November
8 1985, Mr. Aguon began working for the Guam Community College as Payroll
9 Coordinator, later transferring to Controller of the College, February 27, 1989;
10 and

11 **WHEREAS**, Mr. Aguon started working at the Department of
12 Administration on April 9, 1990, where he continued working until his
13 retirement on April 25, 2008; and

14 **WHEREAS**, Peter Aguon is a hard-working and friendly person, very
15 dedicated and responsible, and the government of Guam has benefited greatly
16 from his good work from 1977 to 2008 in the various departments of the
17 government involved with finance; and

18 **WHEREAS**, Mr. Aguon earned a number of commendations from past
19 government Directors and clients, thanking him especially for his help in
20 solving problems, and he also received commendations from various
21 Governors for his unselfish volunteer work helping with a variety of
22 government sponsored programs, conferences, and off-island official visitors;


1 **WHEREAS**, Mr. Aguon was a strong supporter of the Association of
