ADD SECTION 18.02.01, .02 and .03 to RULE XVIII of the Standing Rules

Section 18.02.01 POWER TO SIT AND ACT

For the purpose of carrying out any of its functions and duties under this rule, *I Liheslaturan Guåhan* and a committee or subcommittee is authorized

- (a) To sit and act at such times and places within Guam, whether *I Liheslaturan Guåhan* is in session, has recessed, or has adjourned, and to hold such hearing as it considers necessary; and
- (b) To require, by subpoena or otherwise, the attendance and testimony of such witness and the production of such books, records, correspondence, memoranda, papers and documents as it considers necessary. Subpoenas shall be issued and enforced pursuant to Chapter 3, Title 2 Guam Code Annotated.

Section 18.02.02 The Speaker or the Chairperson of a Standing Committee or a member designated by the chairperson may call or conduct an oversight hearing which shall be in accordance with the public notice requirement of Title 5, Guam Code Annotated, Open Government Act.

Section 18.02.03 The Speaker or the Chairperson of a Standing Committee or a member designated by the chairperson may issue a subpoena by majority of the Committee under Section 18.02.01(b) in the conduct of any legislative activity to include, but not limited to, oversight hearings, regular sessions and Committee of the Whole.
