3 **WHEREAS, Yeoman Harold D. Kirk, Jr., enlisted in the United States**
4 **Navy on August 23, 1985; and**

1 **WHEREAS**, Yeoman Harold D. Kirk, Jr., served his country at many
2 duty stations and aboard many distinguished Naval vessels, including the
3 USS Guam (LPH-9), the USS Fortify (MSO 449), the USS Adroit (MSO 509),
4 and the USS Bolder (LST 1190); and

5 **WHEREAS**, Yeoman Harold D. Kirk, Jr., has received numerous honors
6 and awards, including four Navy and Marine Corps Achievement Medals, the
7 Navy Meritorious Unit Commendation Ribbon, the Navy Battle "E" Ribbon,
8 five Navy Good Conduct Medals, and the Global War On Terrorism Services
9 Medal; and

10 **WHEREAS**, Yeoman Harold D. Kirk, Jr., also received the Naval
11 Reserve Meritorious Service Medal, the Naval Reserve Sea Service Medal, two
12 Navy and Marine Corps Overseas Service Ribbons, the Armed Forces Reserve
13 Medal with Silver Hour Glass and M devise, the Navy Rifle (Expert) Medal,
14 the Navy Pistol (Sharpshooter) Medal, and three Flag Letters of
15 Commendation; and

16 **WHEREAS**, in August 2002, Yeoman Harold D. Kirk, Jr., was advanced
17 to Yeoman First Class and was awarded his Aviation Warfare Specialist
18 Wings; and

19 **WHEREAS**, Yeoman First Class Harold D. Kirk, Jr., during his last
20 assignment at the Navy Operational Support Center, Guam, became a plank
21 owner capable of commissioning new commands; and

22 **WHEREAS**, Yeoman Harold D. Kirk, Jr., has chosen to retire and make
23 Guam his home; and

1 **WHEREAS**, Yeoman Harold D. Kirk, Jr., is an active member of the San
2 Isidro, Malojloj, Parish serving as a lector; and

3 **WHEREAS**, Yeoman Harold D. Kirk, Jr., continues to serve the
4 community and his island home; now, therefore, be it
