6 golden years; and


7 **WHEREAS**, this May we gather again to honor our *Manåmko* – the

19 Yona/Talafofo; now, therefore, be it


20 **RESOLVED**, that *I Mina'Bente Nuebi Na Liheslaturan Guåhan* does
