- 4 Government of Guam in June 1987 with the Guam Police Department, where
- 5 he served as a police officer until May 1987, protecting the people of Guam,
- 6 fighting crime and making the community a safer place to live; and

1 WHEREAS, Mr. Camacho then worked for the Department of Public Works, Building Permit Section, from May 1987 to June 1991, as a Building 2 Inspector II, continuing to make Guam a safe place to live; and 3 WHEREAS, during his tenure at the Department of Public Works, Mr. 4 5 Camacho earned Letters of Recognition from both Mr. Benigno M. Palomo, Director of Public Works, and Mr. Jesus Q. Ninete, Sr., Administrator, 6 Building Permits Section, Department of Public Works, for his outstanding 7 performance during a tremendous increase in building permit activities and 8 9 for being a very productive employee of good moral character; and 10 WHEREAS, Mr. Camacho also received Letters of Recognition from 11 both Ho S. Eun, President, Sun Woo Corporation, and Samson Q. Pueyo, 12 General Manager, Elson Builders, for his strong ability to apply and interpret 13 construction plans, his honesty, truthfulness and fair dealing; and 14 WHEREAS, Mr. Camacho then served as a Construction Inspector III 15 with the Guam Housing Corporation from June, 1991 to October, 2001, 16 leading Guam Housing Corporation staff in the inspection of building, 17 plumbing and electrical work in regards to plans, specifications and code 18 requirements, and assisting, among other projects, in the planning and 19 execution of the LADA Estates Housing Project, valued at Eight Million Five 20 Hundred Thousand Dollars (\$8.5M); and 21 WHEREAS, during his tenure with GHC, Mr. Camacho was nominated for "Employee Award for the 4th Quarter 1997" and for "Employee Award 22 for the 1st Quarter 1998", and won the "Employee Award for the 4th Quarter 23

- 10 Mr. Camacho earned the following awards: a Guam Commendation Medal on
- 11 May 13, 2004 and a Guam Commendation Medal on Nov 7, 2005; now,
