**Relative to commending and congratulating Dr. Jerone T. Landstrom upon the recent accomplishment of Board Recertification in Hand Surgery by the American Board of Medical Specialties.**

1           **BE IT RESOLVED BY *I MINA'BENTE NUEBI NA LIHESLATURAN***  
2 ***GUÅHAN*:**

3           **WHEREAS**, Dr. Jerone T. Landstrom was recertified by the American  
4 Board of Surgery in September 2007, with a specialty in Hand Surgery; and

5           **WHEREAS**, Dr. Landstrom has been working at the Pacific Hand  
6 Surgery Center in his specialty on Guam since 1995; and

1           **WHEREAS**, Dr. Landstrom had, previous to private practice, been  
2 stationed at the U.S. Naval Hospital on Guam from 1990 to 1994; and

3           **WHEREAS**, Dr. Landstrom previously worked in the United States  
4 Public Health Service at Truk State Hospital from 1982 to 1986; and

5           **WHEREAS**, Dr. Landstrom is fluent in the Chuukese language and in  
6 Tagalog; and

7           **WHEREAS**, Dr. Landstrom started his educational career by graduating  
8 Summa Cum Laude from the University of Michigan in 1977, and thereafter  
9 received his M.D. degree from Wayne State University with Honors in  
10 Surgery and Anatomy in 1981; and

11           **WHEREAS**, Dr. Landstrom then completed first year Postgraduate  
12 Residency Education at St. John Hospital, second year through fifth year at  
13 Providence Hospital and University of Michigan and Wayne State University  
14 and was honored as Chief Resident of the Year in 1989-90 and Excellence in  
15 Research in 1989; and

16           **WHEREAS**, Dr. Landstrom completed fellowship training in Hand and  
17 Microsurgery at Hand Center of Texas and Baylor College of Medicine for the  
18 sixth (6<sup>th</sup>) year of Post Graduate Residency, and also had a teaching  
19 appointment at the University of Hawaii John A. Burns School of Medicine;

21           **WHEREAS**, Dr. Landstrom has published many articles and performed  
22 numerous lectures on his specialty, in the areas of carpal tunnel syndrome,  
23 breast cancer, laparoscopic surgery, fractures, dislocations, infections, and  
24 penile replantation, and additionally, has served as Chairperson of the Guam

1 Board of Medical Examiners from 2002-2007, is a Diplomat NBMR, Certified  
2 in Basic and Advanced Laprascopic Surgery by USSH, and is ACLS, ATLS,  
3 and BLS Certified; and

4 **WHEREAS**, Dr. Landstrom continues to be involved in research  
5 projects, especially carpal tunnel syndrome; and


6 **WHEREAS**, Dr. Landstrom is married and has three (3) children; and

7 **WHEREAS**, Guam is fortunate in having in the community such a  
8 renowned specialist as Dr. Jerone T. Landstrom, especially since our island is

10 Landstrom has provided wonderful care to those on Guam who would have  
11 normally had to search for his specialty off-island; now, therefore, be it

17 and be it further


18 **RESOLVED**, that the Speaker certify, and the Secretary of the
