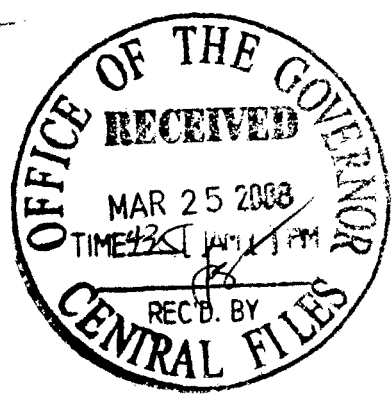



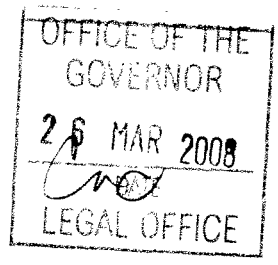
In view of the above, I have no choice but to discontinue this portion of community service which don't allow after working hours.
