

WHEREAS, the late Honorable Juan Lujan Pangelinan, Former Commissioner of the Municipality of Agana Heights, was born on May 18, 1922 and was called to his eternal rest on January 23, 2009, at the age of 86; and

WHEREAS, the late Honorable Juan Lujan Pangelinan was born to and now joins his parents Francisco Borja Pangelinan and Natividad Pangelinan Lujan; and

WHEREAS, in his new life, the late Honorable Juan Lujan Pangelinan now joins his wife Dolores "Lole" Haniu Untalan and his brothers Dory and Do' and his sisters Tita and Francisca, and his grandson Frank J; and

WHEREAS, the late Honorable Juan Lujan Pangelinan was blessed in his marriage with his children and their spouses Frank and Pep and Angie, Toni and Dave Sanford, Tita and Francisco Cruz, Loling and Harold Field, John and June, Gerianne, Joseph and Marie; and

WHEREAS, the late Honorable Juan Lujan Pangelinan was the proud grandfather and great-grandfather of twenty (20) grandchildren and sixteen (16) great-grandchildren; and

WHEREAS, the late Honorable Juan Lujan Pangelinan is additionally survived by his sisters Ninang, Sister Mary Alma, RSM, and Ling; and

WHEREAS, following his successful and historical write-in bid for the office of Commissioner (now known as Mayor) during the General Election of 1952, the late Honorable Juan Lujan Pangelinan was sworn into office and served until the expiration of his term in January 1969; and

WHEREAS, the late Honorable Juan Lujan Pangelinan served the Municipality of Agana Heights with perseverance and dedication; and

WHEREAS, the late Honorable Juan Lujan Pangelinan, throughout his term in office, was instrumental in bringing about improvements to the village of Agana Heights most notably as the founder of the Agana Heights Drum & Bugle Corps, Majorettes and Armed Drill Team;

the first village to construct School Bus Shelters, coordination of "Tent City" after Typhoon Karen; and

WHEREAS, the late Honorable Juan Lujan Pangelinan had a passion for genealogy by publishing family books for "Familian Kotla" and "Familian Haniu" and had in progress family books for "Familian Lujan" and "Familian Untalan"; and

WHEREAS, the late Honorable Juan Lujan Pangelinan was fondly called "Kotla", "Juan Hannom", "Juan Katne", and "Juan Coke", and started Lole's Retail Store or "Kotla Store", Villa Kotla, and "Kotla's Wash & Dri"; and

WHEREAS, the late Honorable Juan Lujan Pangelinan also served as a member of the Young Men's League of Guam (YMLG), Agana Heights Holy Name Society, Agana Heights May Fair Fundraising Committee; *now therefore be it* 

**RESOLVED**, that the Mayors' Council of Guam does hereby, on behalf of the residents of Agana Heights and the people of Guam, express its heartfelt condolences to the family and friends of the late Honorable Juan Lujan Pangelinan, former Commissioner of the Municipality of Agana Heights, on the passing of this honorable and true public servant; *and be it further* 

**RESOLVED**, that the President certify to and the Council Secretary attests the adoption hereof, and that copies of the same be thereafter transmitted to the family of the late Honorable Juan Lujan Pangelinan; the Honorable Paul M.
