

AN ACT TO REINSTATE THE ONE-STEP MERIT PAY INCREASE FOR GRADUATES OF THE PEDRO 'DOC' SANCHEZ SCHOLARSHIP PROGRAM, THROUGH *AMENDING* SUBSECTION (e) AND *ADDING* A NEW SUBSECTION (g) TO §15906, ARTICLE 9, CHAPTER 15, TITLE 17, GUAM CODE ANNOTATED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds 3 that the economic condition of Guam is exhibiting some signs of improvement and 4 increased business activity. This positive economic trend should enable the 5 government of Guam to restore educational incentives which were created to 6 encourage public employees to pursue higher education and training that will enhance their service and contribution in the public sector. A particular incentive
that was initially discontinued in 1998 as a result of austerity measures
implemented government-wide at the time was the merit pay increase for graduates
of the Pedro "Doc" Sanchez Scholarship Program.

This incentive benefit is the one-step merit pay adjustment for government 5 6 of Guam employees who graduate under the Pedro "Doc" Sanchez Scholarship 7 Program. Graduates of the program receive a degree in Public or Business 8 Administration, with an assurance that the participating employee possesses the knowledge and skills to be effective and responsible public servants, thus 9 10 deserving of a one-step merit pay increase. The goal of the Pedro "Doc" Sanchez 11 Scholarship Program is to establish a workforce of well-educated and trained 12 public administrators who will, upon completion of their degree, remain employed 13 with the government of Guam and further apply their knowledge and expertise in their respective agencies. The net effect of this program would be a skilled and 14 educated workforce that will provide more efficient and effective government 15 services to the people of Guam. 16

Therefore, it is the intent of *I Liheslaturan Guåhan* to recognize the importance of insuring that the government of Guam continues to encourage its employees, in particular the supervisors and administrators, to pursue increased educational training opportunities through the Pedro "Doc" Sanchez Scholarship Program. In return, an incentive would be applied to the compensation of the employee through the restoration of a one-step merit pay increase.

23 Section 2. Subsection (e) of §15906, Article 9, Chapter 15, Title 17, Guam
24 Code Annotated, is hereby *amended* to read:

25 "(e) Upon the effective date of this Act, the grantee will be eligible for
26 a mandatory pay merit increase upon graduation. The grantees entered into
27 the program, as evidenced with the awarding of an undergraduate *or*

1graduate degree in Public Administration or Business Administration by the2University of Guam, shall be entitled to receive a one-step merit pay raise3from the department, agency, office, autonomous or semi-autonomous4instrumentality of the government of Guam or the Judiciary in which he or5she is employed effective FY2008 following official certification by the6University of Guam that the grantee has completed all degree requirements.

7 Government Employees who were enrolled in the Pedro "Doc" 8 Sanchez Scholarship Program and graduated with a degree between the enactment of Public Law 23-111 and the enactment of this Section who 9 10 would otherwise have received the one-step merit pay raise, shall be entitled to the same incentive benefit, provided that the employee is an active 11 employee at the time of enactment of this Section and the merit pay increase 12 13 shall not be retroactive. Awarding of the one-step merit pay raise shall be subject to the availability of funds." 14

15 Section 3. A new subsection (g) is hereby *added* to §15906, Article 9,
16 Chapter 15, Title 17, Guam Code Annotated, to read as follows:

"(g) The provisions of subsection (e) of this Section *shall not* apply to
any new enrollees of the Pedro "Doc" Sanchez Program after December 31, 2008."
