Public Law No. 29-143



1           **§4A102. Use of a Minor.** It is unlawful for any individual eighteen  
2 (18) *or* more years of age knowingly *or* intentionally to solicit, induce,  
3 encourage, intimidate, employ, hire, *or* use an individual under eighteen (18)  
4 years of age to unlawfully transport, carry, sell, give away, prepare for sale, *or*  
5 peddle any controlled substance.

6           **§4A103. First Offense Penalty.** A person who violates §4A102 is  
7 guilty of a second degree felony and upon conviction is punishable by a  
8 mandatory term of incarceration in a correctional facility of *not less than* ten  
9 (10) years and *not more than* twenty (20) years and a fine of up to Three  
10 Hundred Thousand Dollars (\$300,000).

11           **§4A104. Second Offense Penalty.** An individual who violates  
12 §4A102 of this Article after a previous conviction under that Section is  
13 punishable by a mandatory term of incarceration in a correctional facility of *not*  
14 *less than* twenty (20) years and *not more than* life and a fine of up to Five  
15 Hundred Thousand Dollars (\$500,000).

16           **§4A105. Ignorance of Age is Not a Defense.** It is *not* a defense to a  
17 violation of this Article that the accused did *not* know the age of the individual  
18 protected under this Article.

19           **§4A106. Mandatory Sentence.** Notwithstanding any other provision  
20 of this Chapter (Guam Uniform Controlled Substance Act), with respect to an  
21 individual who is found to have violated this Article, adjudication of guilt *or*  
22 imposition of sentence may *not* be suspended, deferred, *or* withheld; *nor* may  
23 the individual be eligible for parole before serving the mandatory term of  
24 incarceration prescribed by this Article.

1           **§4A107. Severability Clause.** *If* any provision of this Article, or its  
2 application to any person or circumstance, is held invalid, that determination  
3 shall *not* affect the provisions or applications of this Article that can be given  
4 effect without the invalid provision or application, and to that end the  
5 provisions of this Article are severable.”
