AN ACT TO REZONE A CERTAIN PARCEL IN THE MUNICIPALITY OF BARRIGADA FROM AGRICULTURAL (A) TO COMMERCIAL (C) ZONE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings. The owner of the subject property, Concepcion P. Pablo, is seeking the assistance of *I Liheslatura* to rezone her property from Agricultural (A) to Commercial (C) zone for the purpose of maximizing its potential use. *I Liheslatura* finds that the subject property is partially bounded on the north by Lot 5221-2-1, which is zoned Commercial (C), and the access road to Route 16, on the east by Lot 5223-7-R2, which is owned by the government of Guam, on the south by the A.B. Won Pat Guam International
Airport Authority perimeter fence, and on the west by government of Guam Lot
5169, which is zoned Light Industrial (M1).
