RELATIVE TO HONORING THE MEMORIALIZING THE LATE HONORABLE ALFRED SAN NICOLAS FLORES FOR HIS LONG, DEDICATED, AND UNSELFISH SERVICE TO THE PEOPLE OF INARAJAN AND THE PEOPLE OF GUAM, AND TO EXTENDING A HEARTFELT *SI YU'OS MA'ASE* AND SINCERE CONDOLENCES TO HIS WIFE MRS. ESTER DUENAS FLORES, HIS FAMILY, AND ALL OF THEIR RELATIVE AND FRIENDS.

BE IT RESOLVED BY THE MAYORS' COUNCIL OF GUAM:

WHEREAS, the late Honorable Alfred San Nicolas Flores was born on June 20, 1916 to the late Jose Duenas Flores and the late Rafaela Lujan San Nicolas; and also reared by his stepmother, the late Margarita L. Flores and was called to go back home to his eternal rest on February 6, 2009, at the golden age of ninety-two (92); and

WHEREAS, the late Honorable Alfred San Nicolas Flores met and married a devoted and faithful woman, Mrs. Ester Paulino Duenas Flores, and together were blessed with two (2) daughters, Mrs. Lucille Flores Leon Guerrero and Mrs. May Flores-Hannah and one (1) son, Mr. Fred D. Flores; and a reared son, Mr. Roy P. Duenas; and they were further blessed with ten (10) grandchildren, Giovanna, Alfred, Mark, Brian, Ester, Kristina, David, AnaMaria, Tera, and Fred Jr.; and thirteen (13) great-grandchildren, Kristen, Danielle, Aaron, Giana, Alfred, Sophia, Olivia, David, Johnalyn, Brianne, Erwin Jr., Aubrey, and the late Rachael; and

WHEREAS, the late Honorable Alfred San Nicolas Flores was an ardent and productive lancheru who tended hundreds of acres of land, raised animals and planted fruits and vegetables all for the benefit of supporting his family and even his fellow villagers of Inalahan; and

WHEREAS, the late Honorable Alfred San Nicolas Flores served the people of Guam as an Assemblyman in the Pre-War Congress and was further elected Senator in the Fourth, Fifth, Sixth, Seventh, Ninth, and Tenth Guam Legislatures; and

WHEREAS, the late Honorable Alfred San Nicolas Flores also served as Commissioner (now called Mayor) of Inalahan for one term in 1976; and

WHEREAS, the late Honorable Alfred San Nicolas Flores also served in various boards and commissions including the Selective Service Board, wherein he was a member for twenty-one (21) years, the Guam Housing and Urban Renewal Authority Board of Directors, the Guam Farmers Cooperative Association, and the Soil and Water Conservation District ; and

WHEREAS, the late Honorable Alfred San Nicolas Flores was also active in numerous civic and religious organizations including the Parish Council and Holy Name Society at Saint Joseph's Church in Inalahan; the Boys Scouts of America; the Democratic Party of Guam for which he was well known as "Davy Crockett" and his famous tag line, "*Bai hu puno' I toro!*"; and

WHEREAS, the late Honorable Alfred San Nicolas Flores will be missed but never forgotten and his legacy lives on through his honorable service to God and to his island and in the memories of his wife, children, grand-children, great-grandchildren, his brothers and sisters and their spouses, and his in-laws and their spouses, his numerous relatives and friends; and

WHEREAS, the late Honorable Alfred San Nicolas Flores, throughout his life, was an important and valuable asset in the development of Guam's social, economic, and political history; *now therefore be it*

RESOLVED, that the *Konsehelon Mahot Guåhan* does hereby, on behalf of the people of Inalahan, and the people of Guam, honor and memorialize the Honorable Alfred San Nicolas Flores for his long, dedicated, and unselfish service; *and be it further*


